I am writing to outline my concerns regarding the deepening crisis in Kashmir and the Indian government's decision to remove Article 370.

I am alarmed by Prime minister Modi's abolition of the seven-decade privileged status of Indian-administered Kashmir as detailed in Article 370. This bill, which has been passed through the Indian parliament, means Kashmir will be split into two territories governed directly by Delhi.

The removal of Article 370, and the special status of Kashmir, means the Indian government is illegally removing the sovereignty of the Kashmiri people. This is a blatant attack on the independent status of Kashmir and a violation of its' prerogative to self-govern.

I am particularly concerned by the Indian government's decision to send 38,000 more military officers to the region to enforce this decision. This is on top of the already 700,000 strong forces stationed there. India has cut off all internet and telephone networks in the region and public gatherings have been forbidden, contributing to the Kashmiri people's distress.

It is worrying that there are reports of political leaders and activists, including two former chief ministers of Jammu and Kashmir, being incarcerated. Further, a number of Kashmiri's have been the victims of violence and oppression at the hands of government-controlled security forces who have indiscriminately used harmful weapons, such as pellet-firing shotguns, on Kashmir's citizens.

The Indian government's decision will have far-reaching consequences and has the potential to exacerbate simmering geo-political tensions in the region. As it stands, Pakistan has called India's revocation of Article 370 an illegal occupation and has cut diplomatic ties and suspended trade with India as a result.

India should not be inflicting further harm on the region as this could lead to long-term instability for the entire Indian sub-continent. It could also catalyse an escalation in religious violence and abuses directed towards

India's Muslim population.

I believe the UK government should ask our Indian counterparts to repeal unjust laws like the Public Safety

Act and the Armed Forces Special Powers Act which gives government forces immunity and encourages them

to act violently towards Kashmiris.

We should also press for the Indian government to conform with international human rights law in relation to

the people of Jammu and Kashmir, begin the process of demilitarisation, and conduct the plebiscite as mutually

agreed in the Indian-occupied part of Kashmir via UN Security Council Resolutions.

The Indian government's unilateral abrogation of Article 370 should be condemned, and it should be held

responsible for the repression experienced by Kashmiri people thus far.

As you will know, I have been engaged with the Rohingya refugee crisis for some time and there are clear

parallels with their situation and that of the Kashmiris. There are Rohingya people currently in Kashmir who

have become a target of violence carried out by Indian security forces. Disturbingly, there are reports that the

ferocity of these attacks has increased in recent weeks as a result of the government's announcement to abolish

Article 370 which has stirred nationalist and anti-Muslim sentiment in the region.

In light of these troubling developments, I would be grateful if you could meet with me and representatives

from the St Albans Islamic Centre to discuss the worsening situation in Kashmir and what this government
